FWL-2F and FWL-2 **Pressure-Only Safety Relief Valve**

The Cash Acme FWL-2F and FWL-2 are pressure only safety relief valves designed specifically for the protection of hot water supply systems where over-pressure conditions are likely to occur as a result of thermal expansion. Completely automatic, they reseat after pressure relief. The valve may be installed directly on the tank or in a tee and is appropriate for either side (hot or cold) of the water heater. Available in 1/2" (FWL-2 only) and 3/4" sizes with a male inlet and female outlet. The standard factory relief setting is 150 psi (75 and 125 psi also available). They are fitted with an all bronze body, brass and stainless steel internal parts, a silicone seat disc, and a stainless steel pressure spring. The FWL-2F and 3/4" FWL-2 are Lead Free*.




